Adoption Terms and Conditions:

1. Adoption Fee

The Adopter agrees to pay the adoption fee as determined by the Shelter or Rescue Organization. This fee is non-refundable and covers the costs of veterinary care, spay/neuter, vaccinations, and microchipping.

2. Care and Custody

The Adopter agrees to provide the Animal with adequate food, water, shelter, veterinary care, and humane treatment at all times. The Animal shall not be subjected to neglect, abuse, or abandonment.

3. Health Warranty

The Shelter provides no guarantees as to the Animal's future health. The Animal is adopted AS-IS, WHERE-IS. The Adopter accepts responsibility for all future veterinary and other costs after the date of adoption.

4. Return Policy

If the Adopter is unable or unwilling to keep the Animal at any point, the Adopter agrees to notify the Shelter immediately and arrange for the Animal's return. The Animal shall not be transferred or sold to another party without prior written consent from the Shelter.

5. Compliance with Laws

The Adopter agrees to comply with all federal, state, and local laws regarding Animal ownership, licensing, and care.

6. Right of Inspection

The Shelter reserves the right to conduct reasonable follow-up visits or calls to ensure the Animal's welfare. Refusal to allow such inspection may result in repossession of the Animal.

7. Liability Release

The Adopter agrees to hold harmless and indemnify the Shelter, its employees, volunteers, and agents from any liability resulting from the Animal's behavior or health after adoption.

8. Enforcement

This Agreement constitutes a binding legal contract enforceable under United States law. Any breach may result in legal action, including repossession of the Animal and recovery of fees and costs.

9. Entire Agreement

This Agreement represents the entire understanding between the parties and supersedes all prior negotiations, representations, or agreements, oral or written.

10. Governing Law and Jurisdiction

This Agreement shall be governed by the laws of the State of _____. The parties consent to the exclusive jurisdiction of the state and federal courts located in _____ County, _____.
