Daycare Policies and Agreements:

1. Enrollment and Attendance

The Parent/Guardian agrees to comply with the daycare's enrollment requirements and attendance policies, including timely drop-off and pick-up of the child. The daycare reserves the right to terminate services for failure to comply.

2. Health and Safety

Parent/Guardian certifies that the child is in good health and will notify the daycare immediately of any contagious illness or conditions. The daycare will take reasonable measures to ensure the child's safety but is not liable for unforeseen accidents.

3. Medication Authorization

Parent/Guardian authorizes the daycare staff to administer medications as prescribed and provided in original containers

with clear instructions. All medications must be disclosed and discussed prior to administration.

4. Emergency Medical Care

In the event of an emergency, the daycare is authorized to seek medical treatment for the child, including transportation to a medical facility if necessary. Parent/Guardian will be notified as soon as possible.

5. Fees and Payment

Parent/Guardian agrees to pay all fees according to the daycare's schedule. Late payments may incur additional charges or termination of service.

6. Confidentiality

All personal information collected will be kept confidential and used solely for purposes related to the childcare services and legal compliance.

7. Photographs and Media Release

Parent/Guardian consents that photographs or videos of the child may be taken and used for daycare-related promotional, educational, or record-keeping purposes unless otherwise stated.

8. Termination of Services

Either party may terminate the childcare agreement with written notice. The daycare reserves the right to terminate services immediately for violations of policies or safety concerns.

9. Liability Waiver

Parent/Guardian agrees to hold harmless the daycare and its employees from any claims, damages, or injuries arising from the child's participation in daycare activities, except those caused by gross negligence or willful misconduct.
