I acknowledge that the Producer may edit, modify, or alter the materials that include my likeness as it sees fit, and I waive any right to inspect or approve such materials prior to their use or distribution.

No Obligation:

I understand that the Producer is under no obligation to use any of the rights granted herein or to produce or distribute the Production.
