5. Governing Law

This Authorization Form shall be governed by and construed in accordance with the laws of the United States and the applicable state laws where the authorization is executed or enforced.

6. Severability

If any provision of this Authorization Form is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

7. Entire Agreement

This Authorization Form constitutes the entire agreement between the Principal and Authorized Agent regarding this authorization and supersedes all prior communications, whether written or oral.

8. Binding Effect

This Authorization Form shall be binding upon the Principal, the Authorized Agent, and their respective heirs, legal representatives, successors, and assigns.
