Clause 1 – Agreement to Provide Tutoring Services

Tutor agrees to provide tutoring services to Student as described in this Agreement. Tutor represents having the necessary qualifications, skills, and certifications to provide such services.

Clause 2 – No Guarantee of Results

Tutor makes no guarantees or warranties regarding Student's academic improvement or outcomes resulting from the tutoring sessions.

Clause 3 – Scheduling and Attendance

Sessions will be scheduled as mutually agreed upon. Cancellations must be communicated at least 24 hours in advance. Missed sessions without adequate notice may not be rescheduled or refunded.

Clause 4 – Payment Obligations

Client agrees to pay Tutor the agreed rate per session according to the payment schedule. Late payments may incur fees or suspension of services.

Clause 5 – Confidentiality

Tutor agrees to maintain confidentiality of all Student and Client information except as required by law or with prior written consent.

Clause 6 – Term and Termination

This Agreement remains effective until terminated by either party upon written notice. Outstanding fees become immediately due upon termination.

Clause 7 – Liability Limitation

Tutor shall not be liable for any indirect, incidental, or consequential damages arising from the tutoring services.

Clause 8 – Compliance with Law

Parties agree to comply with all applicable federal, state, and local laws and regulations in performance of this Agreement.

Clause 9 – Amendments

Any amendments or modifications to this Agreement must be in writing and signed by both parties.

Clause 10 – Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements or understandings.

Clause 11 – Dispute Resolution

Any disputes arising under this Agreement shall be resolved through good faith negotiation or mediation before pursuing legal action.

Clause 12 – Governing Law and Venue

This Agreement shall be governed by the laws of the State of _____. Any legal proceedings shall be brought exclusively in the courts located within _____ County, _____.

Clause 13 – Severability

If any provision of this Agreement is held to be invalid or unenforceable, the remainder shall continue in full force and effect.

Clause 14 – Independent Contractor

Tutor is an independent contractor and not an employee or agent of Client.

Clause 15 – Notices

All notices under this Agreement shall be in writing and delivered personally, by certified mail, or by recognized overnight courier to the addresses provided herein.

Clause 16 – Indemnification

Client agrees to indemnify and hold Tutor harmless from any claims, liabilities, or expenses arising out of Student's actions during tutoring sessions.

Clause 17 – Health and Safety

Client shall inform Tutor of any health issues or special needs Student may have relevant to the tutoring sessions.

Clause 18 – Recording Prohibition

No party shall record tutoring sessions without the explicit written consent of all parties involved.

Clause 19 – Force Majeure

Neither party shall be liable for failure to perform due to causes beyond their reasonable control, including natural disasters, pandemics, or acts of government.

Clause 20 – Signatures and Counterparts

This Agreement may be executed in counterparts, each of which shall be deemed an original and all of which together constitute one instrument.
