I waive any right to inspect or approve the finished product or the use to which it may be applied. I release, discharge, and hold harmless the Producer and its representatives from any claims, demands, or causes of action that I may have by reason of anything contained in the Recordings or the use thereof, including any claims for defamation, invasion of privacy, or infringement of moral rights or rights of publicity or copyright.

### Participant Representations and Warranties:

I represent and warrant that I am at least 18 years of age and have full legal capacity to enter into this agreement. If I am under 18 years of age, my parent or legal guardian has also signed this form and agrees to its terms on my behalf. I have read this consent and release prior to signing and fully understand its contents, meaning, and impact.

### Use of Recordings:

The Recordings may be used for any lawful purpose including, but not limited to, promotional, advertising, educational, and commercial purposes. The Producer shall have the exclusive right to edit, crop, or modify the Recordings as it sees fit.

### No Obligation to Use:

I understand that the Producer is under no obligation to use the Recordings or to exercise any of the rights granted herein.

### Confidentiality and Privacy:

The Producer agrees to use reasonable efforts to protect my personal information and to comply with applicable privacy laws. However, I understand that the Recordings themselves may be distributed publicly and are not subject to confidentiality.

### Indemnification:

I agree to indemnify and hold harmless the Producer from any claims, damages, or liabilities arising out of my breach of this agreement or my participation in the event or activity.

**Governing Law and Jurisdiction:**

This Agreement shall be governed by and construed under the laws of the United States and the applicable state jurisdiction. Any disputes arising from this Agreement shall be subject to the exclusive jurisdiction of the state or federal courts located in the appropriate venue.

**Severability:**

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

**Entire Agreement:**
