1. Agreement to Purchase and Deliver

3. Cancellation and Refunds

Cancellations made at least 14 days prior to the event date will receive a full refund of deposits. Cancellations made within 14 days are subject to forfeiture of the deposit.

4. Liability

Florist shall not be liable for any indirect, incidental, or consequential damages arising from the delivery or use of the floral arrangements.

5. Substitutions

Florist reserves the right to substitute flowers of equal or greater value if ordered varieties are unavailable.

6. Delivery and Setup

Delivery times and setup locations must be agreed upon in advance. Any changes may incur additional fees.

7. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the United States of America and the applicable state law where the Florist operates.

8. Entire Agreement

This document constitutes the entire agreement between the parties and supersedes all prior negotiations, agreements, or understandings.

9. Amendments

Any amendments to this Agreement must be made in writing and signed by both parties.
